

WaterAid Dorset Support Group: Privacy Policy

Preservation of your privacy is important to the WaterAid Dorset Support Group [WADSG] and we wish to let you know how we use your personal information and that we make only responsible use of your data.

References to “we”, “us” or “our” in this privacy statement are references to the WaterAid Dorset Support Group, which is an interest group without any formal status. This statement relates to supporters associated with the WaterAid Dorset Support Group.

1. What personal data we collect

The WaterAid Dorset Support Group is an informal group and we collect details about you when you show interest as a supporter of WaterAid. When you express interest in being a supporter of WADSG you will give us such information about yourself as you see fit.

This information might include the name you give us, your email address and phone number, possibly your postal address. We may ask for some non-personal data (e.g. how you heard about the WaterAid Dorset Support Group or the activities you are interested in supporting).

You are responsible for making sure you give us accurate and up to date information.

We will also collect personal data when you access our website. Depending on the approach path you take to us, the way we collect data includes but is not limited to the following:

Downloadable resources - name and email address, possibly phone number.

Event sign up – name, email address, possibly phone number

2. How we use your personal data

We use your personal information for the sole purpose of keeping you informed about events we are organising, asking for your support with them, or inviting you to attend them. We never share your information with third parties without your specific consent.

3. Supporter communications

As a supporter, you will hear from us when conditions apply as above in § 2.

You may withdraw your consent from receiving our communications at any time and/or may stipulate in what form(s) you wish or do not wish to be contacted. If we are no longer allowed to communicate with you, this will impair your contact with the WADSG and reduce your ability to support its activities.

4. Your right to be informed

a) To update your data

If you wish to access or correct or change your personal data that has been collected (see § 1), please contact wateraidsg@yahoo.co.uk and we will respond to your request within one calendar month.

b) To delete your data

If you wish to have your data removed entirely from our records, please contact wateraidsg@yahoo.co.uk and we will respond to your request within one calendar month.

Please note that for legal reasons we are required to keep financial/transactional records for a minimum period of six years from the end of the financial year in which the transaction was made.

c) To object to, or restrict data processing

If you object to the processing of your personal data, or wish to restrict the way in which it is processed by us, please contact wateraidsg@yahoo.co.uk and we will respond as soon as possible. Please note that this may affect our ability to keep in touch with you.

5. How long we retain your data

We retain your personal data only for as long as you wish us to do so. [see § 4 b)]

6. Questions or complaints

If you have questions or a complaint about the way your personal data has been processed by us, please email wateraidsg@yahoo.co.uk and we will look in to this for you as a matter of priority.
